"RESOLVED, to adopt:

ORDINANCE NO. 22

AN ORDINANCE AMENDING ORDINANCE NO. 12-A, SERIES OF 1965,
ENTITLED "AN ORDINANCE REQUIRING ANNUAL PERMIT AND
INSPECTION OF ALL BUSINESS, TRADES OR OCCUPATIONS,
PRESCRIBING FEES THEREFOR AND FOR OTHER PURPOSES."

BE IT ORDAINED by the Municipal Board of Ormoc City, Philippines,
That:

SECTION 1. Ordinance No. 12-A, series of 1965, entitled "An Ordinance Requiring Annual Permit and Inspection of All Business, Trades or Occupations, Prescribing Fees therefor and for other Purposes," is hereby amended by inserting a new sub-paragraph between Section 1-49(b) and Section 2 thereof to be known as Section 1-49(c) which shall read as follows:

"SECTION 1-49(c). Three wheeled motor vehicle .. P10.00"

SECTION 2. This Ordinance shall take effect immediately upon its approval.
