"RESOLVED, to adopt:

ORDINANCE NO. 23

AN ORDINANCE CLOSING CERTAIN PORTIONS OF CITY STREETS TO VEHICULAR TRAFFIC FOR THE DURATION OF THE 1966 ORMOC CITY FESTIVAL AND FOR OTHER PURPOSES

BE IT ORDAINED by the Municipal Board of Ormoc City, That:

SECTION 1. To accommodate transient or chance vendors as well as games, amusements and other activities the following portions of city streets are hereby closed to vehicular traffic for the duration of the 1966 Ormoc City Festival, viz:

a) On Rizal Street - at the right half-side facing Cantubo from its corner of Lopez Jaena Street up to San Agustin Street except its cross sections abutting on Lopez Jaena, Osmeña and San Agustin Streets: PROVIDED, HOWEVER, that no sound system, public address system or the like shall be allowed therein;

b) On William Bryan Street - from its corner of Lopez Jaena Street up down to the seashore except its cross sections abutting on Lopez Jaena and Ciriaco Aviles Streets; and

c) On Padre Burgos Street - from the city motor pool vicinity down to its dead end corner of William Bryan Street only.

SECTION 2. This Ordinance shall take effect immediately upon its approval up to and including July 4, 1966, only.

ENACTED, June 1, 1966.

"RESOLVED, FINALLY, to furnish a copy of this Ordinance each to the City Engineer, the City Treasurer, the City Auditor, the Market Administrator and all concerned, especially the Head of Traffic Division, OCPD, all of Ormoc City;
