"RESOLVED, to adopt:

ORDINANCE NO. 24

AN ORDINANCE AMENDING ORDINANCE NO. 23, SERIES OF 1966, ENTITLED "AN ORDINANCE CLOSING CERTAIN PORTIONS OF CITY STREETS TO VEHICULAR TRAFFIC FOR THE DURATION OF THE 1966 ORMOC CITY FESTIVAL AND FOR OTHER PURPOSES."

BE IT ORDAINED by the Municipal Board of Ormoc City That:

SECTION 1. Ordinance No. 23, series of 1966, entitled "An Ordinance Closing Certain Portions of City Streets for the Duration of the 1966 Ormoc City Festival and for other purposes," is hereby amended by inserting another sub-paragraph between Section 1(c) and Section 2 thereof to be known as "sup-paragraph (d)" which shall read as follows:

"(d) On Rizal Street - at the right-half-side facing the sea, from its corner on Ciriaco Aviles Street down to the seashore except its cross sections on Ciriaco Aviles Street and Padre Burgos Street."

SECTION 2. This Ordinance shall take effect immediately upon its approval.
