"RESOLVED, to adopt:

ORDINANCE NO. 25

AN ORDINANCE AMENDING SUB-PARAGRAPH "D" UNDER SECTION 1 OF
ORDINANCE NO. 23, AS AMENDED, ENTITLED "AN ORDINANCE
CLOSING CERTAIN PORTIONS OF CITY STREETS TO VEHICULAR
TRAFFIC FOR THE DURATION OF THE 1966 ORMOC CITY FESTI-
VAL AND FOR OTHER PURPOSES."

BE IT ORDAINED by the Municipal Board of Ormoc City That:

SECTION 1. Sub-paragraph "d" under Section 1 of Ordinance No. 23,
as amended, is hereby deleted, rescinded and/or amended to read as fol-
lows:

"d) In the middle of Lopez Jaena Street from its inner
corners on Rizal Street to Real Street, leaving six meters
wide open on each side fronting the public market and front-
ing the side from La Leyteña Store to the Mobil Gas station."

SECTION 2. This Ordinance shall take effect immediately upon its
approval.
