

RESOLUTION NO. 145

"The Board, on motion of Floor Leader Tugonon, seconded by Councilors Kierulf, Du and Pongos;

"RESOLVED, to adopt:

ORDINANCE NO. 26

AN ORDINANCE APPROPRIATING ₱282 FOR THE WAGES OF LABORERS UNDERTAKING CONSTRUCTION OF THE SABANG BAO COMMUNITY SCHOOL BUILDING.

BE IT ORDAINED by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of Two Hundred Eighty-Two Pesos (₱282.00), or so much thereof as may be necessary is hereby appropriated out of funds existing in the city treasury not otherwise appropriated said sum to be made available for payment of wages of laborers undertaking the construction of the Sabang Bao Community School building for the period from June 23 to July 8, 1966, inclusive.


SECTION 2. This Ordinance shall take effect immediately upon its approval.
