"RESOLVED, to adopt:

ORDINANCE NO. 27

AN ORDINANCE REVERTING P6,000 FROM THE DISCRETIONARY FUND AND
P6,000 FROM THE BARRIO AND SCHOOL AID FUND, OFFICE OF THE
CITY MAYOR AS INITIAL APPROPRIATION FOR THE IMMEDIATE
CONSTRUCTION OF A SEMI-PERMANENT TEN-ROOMS BUILDING FOR THE
ORMOC CITY HIGH SCHOOL

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of P6,000 or so much thereof as may be necessary
is hereby reverted from the Discretionary Fund and another sum of P6,000
or so much thereof as may be necessary is hereby reverted from the Barrio
and School Aid Fund, Office of the City Mayor, both sums to be made avail-
able for appropriation, initial, in connection with the construction of a
semi-permanent ten-rooms building for the Ormoc City High School.

SECTION 2. This ordinance shall take effect immediately upon its ap-
proval.
