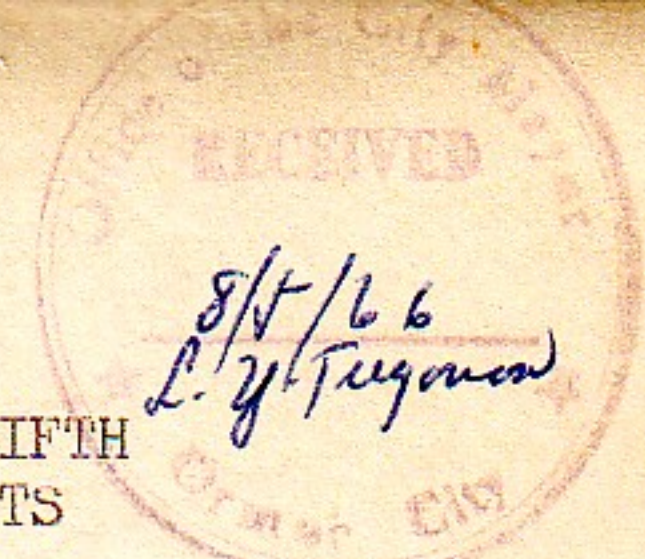

"The Board, on motion of Councilor Du, seconded by Councilor Alfaro;
"RESOLVED, to adopt:

ORDINANCE NO. 28

AN ORDINANCE REVERTING THE ₱6,000 FROM ITEM 39, POLICE DEPARTMENT,
AND ₱1,400 FROM SALARY SAVINGS IN ANY DEPARTMENT OF THE CITY
GOVERNMENT FOR SUPPLEMENTAL APPROPRIATION TO COVER SALARIES
OF NEW TEACHERS FOR BARRIO HIGH SCHOOLS OF ORMOC CITY

BE IT ORDAINED by the Municipal Board of Ormoc City, Philippines,
THAT:

SECTION 1. The sums of ₱6,000 from Item 39, Police Department,
and ₱1,400 from salary savings in any department, **Ormoc** City Budget,
are hereby reverted to be made available for supplemental appropria-
tions to cover salaries of new teachers for the barrio high schools
of Ormoc City.

SECTION 2. This Ordinance shall take effect immediately upon its
approval.
