

"RESOLVED, to adopt:

ORDINANCE NO. 29

AN ORDINANCE APPROPRIATING ₱1,000.00 TO PURCHASE CHEMICALS
FOR DISTRIBUTION TO BARRIOS AFFECTED BY LOCUSTS AND HOPPERS
AS NEED ARISES

BE IT ORDAINED by authority of the Municipal Board of Ormoc City, That:

SECTION 1. The sum of ₱1,000.00, or so much thereof as may be necessary, is hereby appropriated out of funds not otherwise appropriated in the city treasury to be made available for the purchase of chemicals for distribution to barrios affected by locusts and hoppers as the need arises.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
