"RESOLVED, to adopt:

ORDINANCE NO. 30

AN ORDINANCE REVERTING P3,190.00 FROM VARIOUS ITEMS FOR THE
SALARY OF REMEDIOS T. YAP, CITY MIDWIFE

BE IT ORDAINED by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of P3,190.00, or so much thereof as may be necessary, is hereby reverted from various funds in the city treasury to be made available for the payment of salaries of Miss Remedios T. Yap, City Midwife, for the periods from December 1, 1964, to September 30, 1965, at the rate of P130.00 a month (P1,300.00), and from October 1, 1965, to August 15, 1966, at the rate of P180.00 a month (P1,890.00), in the manner hereunder provided, to wit:

a. from Discretionary Fund of the City Mayor	P 2,065.00
b. from salary savings of unfilled position of Administrative Assistant, Health Department	675.00
c. from salary savings of one (1) City Midwife from June 1 to September 15, 1966, inclusive	450.00
T O T A L	P 3,190.00

SECTION 2. This Ordinance shall take effect immediately upon its approval.
