"RESOLVED, to adopt:

ORDINANCE NO. 31

AN ORDINANCE REVERTING P354.52 FROM TRAVELING EXPENSES IN THE
POLICE DEPARTMENT FOR BACK SALARIES AND DIFFERENTIALS OF
PATROLMEN CAYETANO ESTRERA AND HERACLEO MALINAO, RESPECTIVELY.

BE IT ORDAINED by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of P354.52, or so much thereof as may be necessary, is hereby reverted from items on traveling expenses of the Police Department to be made available for the back salaries and salary differentials of the two members of the Ormoc City Police Department in the manner hereunder provided, to wit:

- a. for unpaid salaries during preventive suspension of
Pat. Cayetano Estrera for the period from May 10 to
June 30, 1966, at the rate of P150.00 a month P 250.00
 - b. for salary differentials of Pat. Heracleo Malinao from
P1,800 to P2,160 per annum for the period from Jan-
uary 17 to April 30, 1966, inclusive 104.52

SECTION 2. This Ordinance shall take effect immediately upon its approval.
