

"RESOLVED, to adopt:

ORDI NANCE NO. 34

AN ORDINANCE REVERTING \$400.00 FROM SALARY SAVINGS ACCRUING TO THE AGRICULTURE AND LIVESTOCK INSPECTION DEPARTMENT TO BE MADE AVAILABLE FOR REIMBURSEMENT OF PER DIEMS AND TRAVEL-ENG EXPENSES OF MEAT INSPECTOR CIRILO LAUDE IN CONNECTION WITH HIS IN-SERVICE TRAINING AT THE OFFICE OF THE DISTRICT VETERINARIAN, TACLOBAN CITY, FROM JULY 10 to AUGUST 24, 1956

BE IT ORDAINED by authority of the Municipal Board of Ormoc City, That:

SECTION 1. The sum of Four Hundred Pesos (\$400.00), or so much thereof as may be necessary, is hereby reverted from salary savings (differentials) accruing to the Agriculture and Livestock Inspection Department to be made available for the reimbursement of actualland necessary per diems and traveling expenses of City Meat Inspector Cirilo Laude incurred during his inservice training at the office of the District Veterinarian, Tacloban City, for the period from July 10 to August 24, 1956, inclusive:

SECTION 2. This Ordinance shall take effect immediately upon its approval
