ORDINANCE NO. 36

AN ORDINANCE AMENDING ORDINANCE NO. 12-A, SERIES OF 1965, RE-
QUIRING ANNUAL PERMIT AND INSPECTION ON ALL BUSINESSES,
TRADES OR OCCUPATIONS, PRESCRIBING FEES THEREFOR, AND
FOR OTHER PURPOSES.

BE IT ORDAINED by the Municipal Board of Ormoc City, That:

SECTION 1. Ordinance No. 12-A, series of 1965, entitled "An Or-
dinance Requiring Annual Permit and Inspection On All Businesses,
Trades or Occupations, Prescribing Fees Therefor, and for other Pur-
poses," is hereby amended by inserting one sub-section under Item No.
20 of Section 1 thereof, said insertion to be known as "Subsection C"
which shall read as follows:

"C" "D" For free-lance photographer without gallery .. P5.00"

SECTION 2. This Ordinance shall take effect immediately upon its
approval.
