ORDINANCE NO. 4

AN ORDINANCE APPROPRIATING THE SUM OF \$1,000.00 OUT OF THE STREETS AND BRIDGES FUND TO BE MADE AVAILABLE FOR THE CONSTRUCTION OF A FOOTBRIDGE ACROSS THE ANILAO RIVER WITH THE EXTENSION OF OSMENA STREET TOWARDS SAID RIVER

BE IT ORDAINED by the Municipal Board of Ormoc City, Philippines, That:

SECTION 1. The sum of One Thousand Pesos (\$1,000.00), or so much thereof as may be necessary, is hereby appropriated out of the Streets and Bridges Fund to be made available for the construction of a footbridge under the direct control and supervision of the City Engineer across the Anilao River in the Osmeña Street extension.

SECTION 2. This ordinance shall take effect immediately upon its approval.
