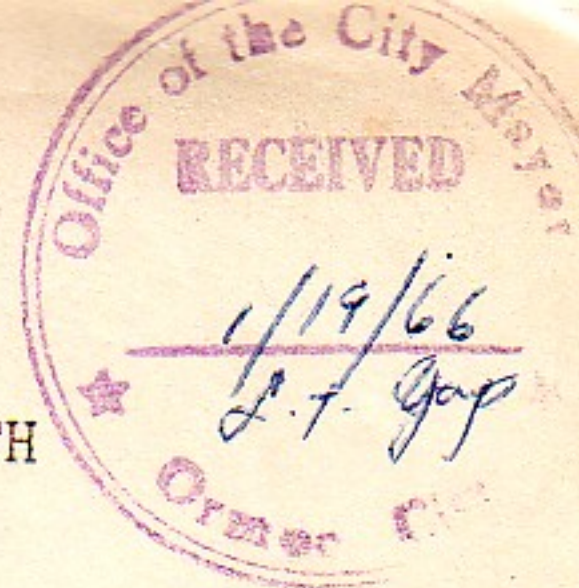

RESOLUTION NO. 10

"WHEREAS, this august Body would now want to push through with its project of a footbridge construction across the Anilao River most preferably with the plan of the City Engineer to extend Osmeña Street towards said river for the convenience of not only the faculty and students of the Ormoc City High School living in the city proper who up to the present have to go around as far as crossing the Cantubo bridge but also the general populace of this City;

"NOW, THEREFORE, the Board, on motion of Councilor Abas, seconded by Floor Leader Tugonon;

"RESOLVED, to adopt:

ORDINANCE NO. 4

AN ORDINANCE APPROPRIATING THE SUM OF ₱1,000.00 OUT OF THE STREETS AND BRIDGES FUND TO BE MADE AVAILABLE FOR THE CONSTRUCTION OF A FOOTBRIDGE ACROSS THE ANILAO RIVER WITH THE EXTENSION OF OSMENA STREET TOWARDS SAID RIVER

BE IT ORDAINED by the Municipal Board of Ormoc City, Philippines, That:

SECTION 1. The sum of One Thousand Pesos (₱1,000.00), or so much thereof as may be necessary, is hereby appropriated out of the Streets and Bridges Fund to be made available for the construction of a footbridge under the direct control and supervision of the City Engineer across the Anilao River in the Osmeña Street extension.

SECTION 2. This ordinance shall take effect immediately upon its approval.

ENACTED, January 12, 1966.
