RESOLUTION NO. 12

"WHEREAS, with the City Administration's program of cementing of city streets and other projects, the acquisition of one concrete mixer (one bagger) has become an imperative necessity considering that the one now being availed of is a National property which might be withdrawn at any moment's notice for its own multifarious program of work;

"NOW, THEREFORE, the Board, on motion of Councilor Abas, seconded by Councilor Du;

"RESOLVED, to adopt:

ORDINANCE NO. 5

AN ORDINANCE APPROPRIATING THE SUM OF ₱2,700.00 OUT OF THE CAPITAL OUTLAY ITEM ON CEMENTING OF CITY STREETS TO BE MADE AVAILABLE FOR THE PURCHASE OF A CONCRETE MIXER (ONE BAGGER) AND FOR OTHER PURPOSES

BE IT ORDAINED by the Municipal Board of Ormoc City, Philippines, That:

SECTION 1. The sum of Two Thousand Seven Hundred Pesos (₱2,700.00) or so much thereof as may be necessary, is hereby appropriated out of the capital outlay item on the cementing of city streets to be made available for the purchase of one (1) concrete mixer (one bagger).

SECTION 2. The City Engineer, thru the City Treasurer, is hereby authorized to negotiate for the acquisition of said concrete mixer.

SECTION 3. This Ordinance shall take effect immediately upon its approval.
