ORDINANCE NO. 5

AN ORDINANCE APPROPRIATING THE SUM OF \$2,700.00 OUT OF THE CAPITAL OUTLAY ITEM ON CEMENTING OF CITY STREETS TO BE MADE AVAILABLE FOR THE PURCHASE OF A CONCRETE MIXER (ONE BAGGER) AND FOR OTHER PURPOSES

BE IT ORDAINED by the Municipal Board of Ormoc City, Philippines, That:

SECTION 1. The sum of Two Thousand Seven Hundred Pesos (\$2,700.00) or so much thereof as may be necessary, is hereby appropriated out of the capital outlay item on the cementing of city streets to be made available for the purchase of one (1) concrete mixer (one bagger).

SECTION 2. The City Engineer, thru the City Treasurer, is hereby authorized to negotiate for the acquisition of said concrete mixer.

SECTION 3. This Ordinance shall take effect immediately upon its approval.
