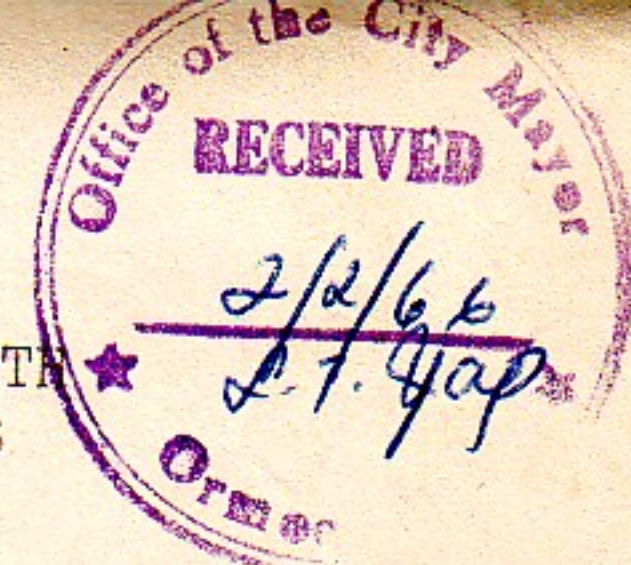

RESOLUTION NO. 17

"The Board, on motion of Councilor Alfaro, seconded by Councilor Besabella;

"RESOLVED, to adopt:

ORDINANCE NO. 6

AN ORDINANCE CREATING ONE MORE POSITION OF PATROLMAN IN THE
ORMOC CITY POLICE DEPARTMENT EFFECTIVE FEBRUARY 16, 1966,
APPROPRIATING FUNDS FOR COMPENSATION THEREOF FROM REVER-
SIONS AND FOR OTHER PURPOSES.

BE IT ORDAINED by the Municipal Board of Ormoc City, Philippines,
That:

SECTION 1. The sum of Eight Hundred Twenty-Five Pesos (P825.00),
or so much thereof as may be necessary, is hereby reverted from salary
savings in any department to be made available for supplemental appro-
priation for the salary of one (1) new position of Patrolman in the
Ormoc City Police Department with compensation at the rate of One Thou-
sand Eight Hundred Pesos (P1,800.00) per annum effective February 16,
1966.

SECTION 2. This Ordinance shall take effect immediately upon its
approval.

ENACTED, February 2, 1966.
