RESOLUTION NO. 18

"WHEREAS, the Honorable Judge of the Court of First Instance of Leyte, 13th Judicial District, Fifth Branch, Ormoc City, has in a communication of even date requested an appropriation for payment of telegrams, purchase of books and office supplies and other contingent expenses for the said Court inasmuch as its appropriation has already been exhausted;

"NOW, THEREFORE, the Board, on motion of Floor Leader Tugonon, seconded by Councilor Alfaro;

"RESOLVED, to adopt:

ORDINANCE NO. 7

AN ORDINANCE REVERTING THE SUM OF THREE THOUSAND PESOS (P3,000) FROM SALARY SAVINGS ACCRUING TO ANY DEPARTMENT AND/OR OFFICE OF THE CITY GOVERNMENT TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR CONTINGENT EXPENSES OF THE COURT OF FIRST INSTANCE, 13TH JUDICIAL DISTRICT, FIFTH BRANCH, ORMOC CITY.

BE IT ORDAINED by the Municipal Board of Ormoc City, Philippines, that:

SECTION 1. The sum of Three Thousand Pesos (P3,000.00), or so much thereof as may be necessary, is hereby reverted from salary savings accruing to any and all departments and/or offices of the City Government to be made available for supplemental appropriation as aid to the Court of First Instance, of Leyte, 13th Judicial District, Fifth Branch, Ormoc City, for contingent expenses of the said Court.

SECTION 2. This Ordinance shall take effect immediately upon its approval.

"RESOLVED, FINALLY, to furnish a copy of this resolution-ordinance each to the Honorable Judge of the Court of First Instance of Leyte, 13th Judicial District, Fifth Branch, Ormoc City, for his information, and the City Auditor and the City Treasurer, both of Ormoc City;

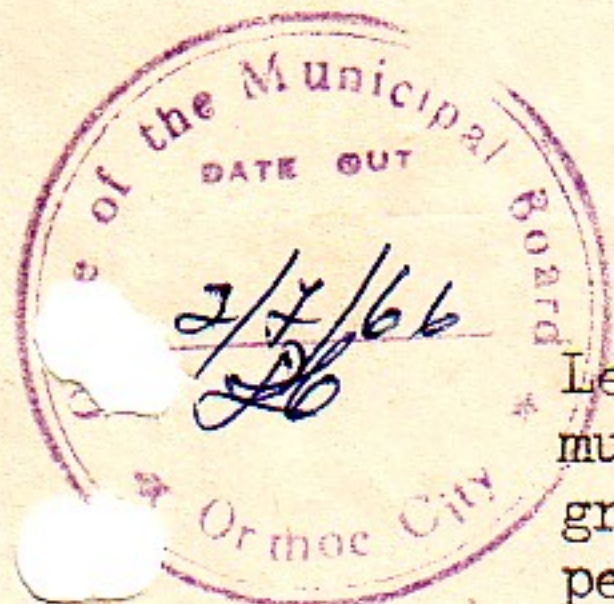
