AN ORDINANCE REVERTING \$10,000 FROM ITEM NO. 13, BARRIO AIDS, PAGE 4, 1965-1966 ORMOC CITY BUDGET, UNDER (C-1) OFFICE OF THE CITY MAYOR, TO BE MADE AVAILABLE FOR APPROPRIATION FOR THE COMPLETION OF PAYMENTS OF TWO FIRE TRUCKS AND FOUR JEEPS TO THE NATIONAL CIVIL DEFENSE ADMINISTRATION, MANILA.

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City,

SECTION 1. The sum of Ten Thousand Pesos (\$10,000.00), or so much thereof as may be necessary, is hereby reverted from Item No. 13, Barrio Aids, page 4, 1965-1966 Ormoc City Budget, under (C-1) Office of the City Mayor, to be made available for appropriation for completion of payments for two fire trucks and four jeeps to the National Civil Defense Administration.

SECTION 2. The City Treasurer is hereby authorized to issue a certificate of the availability of funds for this purpose.

SECTION 3. This Ordinance shall take effect immediately upon its approval.
