## RESOLUTION NO. 47

"The Board, on motion of Councilor Kierulf, seconded by the Floor Leader and Councilor Alfaro;

"RESOLVED, to adopt:

## ORDINANCE NO.

AN ORDINANCE ON SANITATION IN THE PUBLIC MARKET, PROVIDING PENALTIES FOR VIOLATIONS THEREOF, AND FOR OTHER PURPOSES.

BE IT ORDAINED by the Municipal Board of Ormoc City, Philippines, That:

SECTION 1. It shall be unlawful for any occupant or rentee of any stall or establishment within the premises of the public market of this city to make or cause to be made any additional improvement and destroy or cause to be destroyed any part of the stall or establishment without a written permit therefor from the Market Administrator and approved by the City Health Officer.

SECTION 2. It shall, likewise, be unlawful for any such occupant or rentee to have his family or any member thereof to inhabit said stall or establishment: PROVIDED, HOWEVER, that an occupant or bentee may keep one or two persons in the stall or establishment as guards at night whose names, ages, sexes and stall assignment shall be recorded by said rentee or occupant in the office of the Market Administrator.

"To inhibit", as provided for in this ordinance, means to dwell, live or reside in the stall or establishment, singly or collectively to sleep therein and to do the usual family chores therein.

SECTION 3. No person shall conduct any business in the public market unless a sanitary license therefor is issued by the City Health Officer which license shall be renewed quarterly.

SECTION 4. Every occupant or rentee shall keep his stall or establishment clean and orderly for which purpose he shall provide himself with one or more well-covered garbage cans to be conspicuously placed within his premises wherein to dump all his rubbish and garbage.

SECTION 5. The vendor or vendors of any specific commodity shall offer such commodity only in the place designated therefor in the public market.

SECTION 6. The deposit, display or sale of any food or article on streets, aisles, alleys, sidewalks or any space other than the stall itself shall in no case be permitted.

SECTION 7. No evisceration, skinning or any like operation other than cutting of meat into bits or slicing of fish into small pieces to facilitate weighing and sales shall be done in the market or in any space or portion belonging to the market not specified for that purpose. No bones, skins, feathers, or scales of fish and other animals or part of dead animals shall be thrown into the ditch, canal or elsewhere outside the garbage cans.

SECTION 8. No person shall remain sitting, kneeling or lying down on aisles, alleys, passageways, sidewalks or any space where he impedes the flow of traffic or persons passing by.

SECTION 9. Personal belongings such as clothes, hats, baskets, bags, and the like shall not be hanged or placed on or over stalls where meat, fish or vegetables are being sold or displayed.

SECTION 10. The use of stoves for cooking fueled by either wood, charcoal, saw dust or any other material which may cause to emit smoke so as to become a nuisance or health hazard, shall not be allowed within the market premises.

SECTION 11. The sale of any kind of food which is either damaged, dirty, contaminated or in the state of decomposition shall not be allowed and shall be condemned by the City Health Officer whose office shall issue a receipt to owners of such food condemned or destroyed and shall keep at the specific time a record of such receipt showing the name of owner, his age, civil status and address, the quantity and nature of the confiscated food and the date of confiscation.

SECTION 12. Owners of restaurants, carenderias, "painitan", cafeterias, refreshment parlors and the like conducted in the public market shall provide themselves with hot water for washing plates, glasses, cups, dishes, forks, sppons and other sundry utencils or objects and the water used once for such purpose shall not be used again.

SECTION 13. All cooked foods, all preserves such as salted fish, bajong, hipon, sisi and the like, all articles of confectionary, sugar, salt and the like, and all other foods offered for sale shall be maintained at all times well protected against contamination from flies and other insects and against dust or dirts.

SECTION 14. All owners, food handlers, employees, cooks, attendants, waiters or waitresses, servers, laborers or any other persons connected with the operation of restaurants, carenderias, "painitan", cafeterias and other eateries, and all vendors of tuba, seft or alcoholic drinks, fish, meat, vegetables and the like shall provide themselves each with a medical certificate issued by the City Health Officer showing that he is not suffering from any contagious disease and which medical certificate shall be governed by City Ordinance No. 5, series of 1950, as amended.

SECTION 15. No person shall throw, dump or scatter refuse, garbage or rubbish anywhere in the public market premises outside the garbage boxes or cans therein provided.

SECTION 16. No person shall defecate, urinate or throw any fecal matter anywhere in the premises of the public market outside of the market latrine.

SECTION 17. Any violation of the provisions of this ordinance shall be punishable by a fine of not less than ten pesos (\$\mathbb{P}10.00) but not exceeding two hundred pesos (\$\mathbb{P}200.00) or an imprisonment of not less than ten (10) days but not exceeding six (6) months or both such fine and imprisonment at the discretion of the Court.

SECTION 18. Any provision or provisions of any ordinance inconsistent herewith are hereby repealed.

SECTION 19. This ordinance shall take effect immediately upon approval hereof.

ENACTED, June 28, 1967.

"RESOLVED, BURTHER, to authorize the City Health Bepartment to print copies of this Ordinance for distribution and dissemination to stallholders, rentees and the like in the public market and to the general public;

"RESOLVED, FINALLY, to furnish a copy of this resolution each to the City Health Officer, the Market Administrator, the City Judge, the City Fiscal, and the Chief of Police, all of Ormoc City;
