"RESOLVED, to adopt:

ORDINANCE NO. 11

AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱1,300.00 FOR BURIAL EXPENSES OF THE LATE HONORABLE CITY COUNCILOR FRANCISCO D. AVILES

BE IT ORDAINED by the Municipal Board of Ormoc City, That:

SECTION 1. The amount of One Thousand Three Hundred Pesos (₱1,300.00), or so much thereof as may be necessary, is hereby appropriated out of funds existing in the City treasury not otherwise appropriated to be made available for the burial expenses of the Late City Councilor Francisco D. Aviles.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
