ORDINANCE NO. 12

AN ORDINANCE APPROPRIATING P10,000.00 AS CITY COUNTERPART FOR
COMMISSION ON ELECTIONS EXPENSES IN THE FORTHCOMING LOCAL
ELECTIONS

BE IT ORDAINED by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of Ten Thousand Pesos (P10,000.00), or so
much thereof as may be necessary, is hereby appropriated out of funds
existing in the city treasury not otherwise appropriated to be made
available as counterpart of the city with the Commission on Elections
expenses in the coming November, 1967 local elections.

SECTION 2. This Ordinance shall take effect immediately upon its
approval.
