RESOLUTION NO. 70

"WHEREAS, with the retirement of Major Teofilo T. Moncada as Chief of the Fire Department he has been collecting and still will be collecting his vacation and sick leave and/or terminal leave pay from the item of the salary of the Chief of Fire Department up to January, 1968, considering that this august Body has inadvertently failed to provided for an item on gratuity or accumulative vacation and sick leave and/or terminal leave for retired official of the Ormoc City Fire Department and anticipating then that the vacant position of the Chief of the Fire Department will not as yet be filled up until after the expiration of the terminal leave of Major Teofilo T. Moncada;

"WHEREAS, Captain Marcelino Conopio, in the courtesy call he made before this august Body today, has officially informed this Board that he had already assumed the position of Chief of the Fire Department, vice-Major Teofilo T. Moncada, retired, last August 10, 1967, on the heels of an appointment duly signed by His Excellency, the President of the Philippines, Ferdinand E. Marcos;

"WHEREAS, the Assistant and/or Acting City Treasurer made representations before this Board today that his office is facing a problem in the matter of paying the salaries of Captain Marcelino Conopio, the incumbent Chief of the Fire Department, considering that the item for said salaries is already earmarked for the terminal leave of retired Fire Chief Major Teofilo T. Moncada up to January, 1968;

"WHEREAS, this Honorable Board is of the consensus that the services of the Chief of Fire Department could not be utterly dispensed with considering the primary importance of such position in the city government so that it behooves upon this Body to solve the problem now faced by the Office of the City Treasurer in the matter of the salaries of the new Chief of the Fire Department;

"WHEREAS, the City Treasurer has suggested that to remedy the situation it would be best for the Board to appropriate the sum of ₱3,625.00 which, according to him, could easily be secured from the taxes on sugar due the City Government which will be collected in a not-too-distant future, this sum being computed to cover the uncollected terminal leave of the retired Chief of Fire Department up to January;

"NOW, THEREFORE, the Board, on motion of Councilor Abas, seconded by Councilor Du;



"RESOLVED, to adopt:

ORDINANCE NO. 13

AN ORDINANCE APPROPRIATING THE SUM OF THREE THOUSAND SIX HUNDRED TWENTY-FIVE PESOS (P3,625.00) TO BE MADE AVAILABLE FOR THE SALARY OF CAPTAIN MARCELINO CONOPIO, CHIEF OF FIRE DEPARTMENT, FROM AUGUST 10, 1967, UP TO THE END OF THE PERIOD COVERED BY THE TERMINAL LEAVE OF THE RETIRED CHIEF OF FIRE DEPARTMENT, MAJOR TEOFILO T. MONCADA, AVAILING IN THIS CONNECTION THE TAXES ON SUGAR.

BE IT ORDAINED by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of Three Thousand Six Hundred Twenty-Five Pesos (P3,625.00), or so much thereof as may be necessary, is hereby appropriated out of funds not otherwise appropriated availing in this connection the taxes collectible on sugar to be made available for the salary of the new Chief of Fire Department, Captain Marcelino Conopio, for the period from August 10, 1967, up to the end of the period covered by the terminal leave of the retired Chief of Fire Department, Major Teofilo T. Moncada.


SECTION 2. This Ordinance shall take effect immediately upon its approval.

ENACTED, August 16, 1967.


