RESOLUTION NO. 80

"WHEREAS, this august Body has learned that the former Chief of the Fire Department had already collected his terminal leave pay covering the period from the date of his retirement, March 1, 1967, up to and including January 31, 1968, which had been charged against the salary provided for the said position in the Budget Ordinance No. 1, series of 1967, so much so that when Captain Marcelino S. Conopio took over the position vacated by the retired fire chief Major Teofilo T. Moncada the former is now unable to collect his salary for the period from August 10, 1967, date of assumption of office, up to January 31, 1968;

"WHEREAS, this august Body will remember having adopted Resolution No. 68 last August 11, 1967, giving preference to Mrs. Corazon Paz-Aviles to draw the death compensation of her late husband, Honorable City Councilor Francisco D. Aviles, corresponding to five months from August 1 to December 31, 1967, which has been charged against the salary provided for the position of the Late Councilor Aviles in Budget Ordinance No 1, series of 1967, so much so that when Councilor Teotimo P. Ocubillo assumed office on September 1, 1967, there was no more fund available or that he could no longer collect his salary for services rendered as such City Councilor from August 1, 1967, up to the end of his term on December 31, 1967;

"WHEREAS, this Board finds no other recourse to remedy this situation except to revert some savings in the City Treasury accruing to various departments and/or offices of the City Government;

"NOW, THEREFORE, the Board, on motion of Councilor Abas, seconded by Councilors Alfaro and Pongos;

"RESOLVED, to adopt:

ORDINANCE NO. 14

AN ORDINANCE REVERTING THE SUM OF SIX THOUSAND SEVEN HUNDRED FIFTY PESOS (P6,750.00) FROM ANY SAVINGS OF THE MUNICIPAL BOARD, THE POLICE DEPARTMENT, AND THE FIRE DEPARTMENT TO BE MADE AVAILABLE FOR SALARIES OF CAPTAIN MARCELINO S. CONOPIO, CHIEF OF FIRE DEPARTMENT, AND HONORABLE TEOTIMO P. OCUBILLO, CITY COUNCILOR, TO SUPPLEMENT THE PROVISIONS MADE FOR THE PURPOSE UNDER BUDGET ORDINANCE NO. 1, SERIES OF 1967, CONSISTENT WITH ACTUAL REQUIREMENTS.
