RESOLUTION NO. 82

"The Board, on motion of Councilor Kierulf, seconded by Councilor Du;

"RESOLVED, to approve Resolution No. 27, current series, of the Ormoc Puericulture Center Board of Directors, this City, and do, as this Body hereby does, adopt:

ORDINANCE NO. 15

AN ORDINANCE APPROPRIATING P2,000 OR REVERTING THE SAME FROM ANY SAVINGS OF DEPARTMENTS AND/OR OFFICES OF THE CITY TO BE MADE AVAILABLE FOR AID TO THE ORMOC PUERICULTURE CENTER, FOR ITS OPERATION AND MAINTENANCE.

BE IT ORDAINED by the Municipal Board of Ormoc City THAT:

SECTION 1. The sum of P2,000, or so much thereof as may be necessary, is hereby appropriated out of funds existing in the City Treasury not otherwise appropriated, or reverted from any savings of departments or offices of the City Government, to be made available for aid to the Ormoc Puericulture Center for its operation and maintenance.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
