## ORDINANCE NO. 17

AN ORDINANCE ON SANITATION AND ORDERLINESS FOR BUSINESS ESTABLISHMENTS WITHIN ORMOC CITY, PROVIDING PENALTIES FOR VIOLATIONS THEREOF, AND FOR OTHER PURPOSES.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. In order to safeguard the health and promote the welfare of the consuming public, all persons conducting, maintaining, operating or engaged in any kind of business, their employees, laborers and helpers shall be required to get a medical certificate from the City Health Officer attesting to the fact that he is not suffering from any contageous or communicable disease that may endanger the health of his customers. This certificate shall be renewed every six (6) months from date of examination or issue.

SECTION 2. Every occupant or rentee of any business establishment shall keep his place clean and orderly and shall provide himself with at least one well-covered garbage can to be conspicuously placed within his premises wherein to dump all his rubbish and garbage.

SECTION 3. It shall be unlawful for any person to cook, display, deposit or sell any food, article, merchandise on streets, aisles, sidewalks and alleys of any business establishment.

SECTION 4. Any establishment used for business purposes shall provide itself with a "flush" toilet or a water-sealed type of toilet within its premises which shall be clean, amply illuminated and fly-proof.

SECTION 5. The owner, manager or person running the establishment shall at all times keep his establishment and its surroundings clean, orderly and nuisance-free.

SECTION 6. Any person, firm, company or corporation, violating any provision or provisions of this Ordinance shall be punishable by a fine of not less than ten pesos (P10.00) but not exceeding two hundred pesos (P200.00) or an imprisonment of not less than ten (10) days but not exceeding six (6) months, or both such fine and imprisonment at the discretion of the court. In case of a company, corporation or association, the president or manager of such company, corporation or association shall be held responsible for any violation committed by their subordinates.
