RESOLUTION NO. 91

The Board, on motion of Councilor Du, seconded by Councilors Alfaro, Kierulf and Abas;

"RESOLVED, to adopt:

ORDINANCE NO. 21

AN ORDINANCE REVERTING THE SUM OF ₱2,400.00 FROM SALARY SAVINGS OF THE ORMOC CITY POLICE AND OTHER DEPARTMENTS TO BE MADE AVAILABLE FOR SUPPLEMENTAL APPROPRIATION FOR TERMINAL LEAVE PAY AND BURIAL EXPENSES OF THE LATE POLICE LIEUTENANT MAURICIO CODILLA.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of two thousand four hundred pesos (₱2,400.00), or so much thereof as may be necessary, is hereby reverted from out of salary savings accruing to the Ormoc City Police and other Departments to be made available for supplemental appropriation in favor of the late Police Lieutenant Mauricio Codilla who died in line of duty, in the manner provided hereunder, vis-a-vis:

- a) For his terminal leave with pay from July 1, 1967, to March 13, 1968 ₱1,800.00
b) For city's share (50%) of reimbursement of his burial expenses 600.00
T O T A L ₱2,400.00

SECTION 2. This Ordinance shall take effect immediately upon its approval.
