ORDINANCE NO. 24

AN ORDINANCE REVERTING THE SUM OF \$\mathrm{P}\,31,000.00 FROM SALARY SAVINGS AND/OR ANY OTHER SAVINGS IN VARIOUS DEPARTMENTS OF THE CITY GOVERNMENT TO BE MADE AVAILABLE FOR SUPPLEMENTAL APPROPRIATIONS FOR THE OFFICES OF THE CITY MAYOR AND THE MUNICIPAL BOARD FOR CONTINGENT EXPENSES AND FOR OTHER PURPOSES.

BE IT ORDAINED by the Municipal Board of Ormoc City That:

SECTION 1. The aggregate sum of \$\mathbb{P}31,000.00, or so much thereof as may be necessary, is hereby reverted from salary savings and/or any other savings in the various departments of the City Government to be made available for supplemental appropriations for respective contingent expenses of the Offices of the City Mayor and the Municipal Board, particularly, to provide outlays for leave credits for the two departments, vis-a-vis:

1. Office of the City Mayor ₱20,000.00

2. Office of the Municipal Board 11,000,00 ₱ 31,000.00

SECTION 2. This Ordinance shall take effect immediately upon its approval.
