## RESOLUTION NO. 13

"The Board, on motion of Councilor Aviles, seconded by the Floor Leader and Councilors Kierulf and Pongos and Besabella;

"RESOLVED, to adopt:

ORDINANCE NO. 4

AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱2,720.88 TO BE MADE AVAILABLE AS ADDITIONAL SUM TO THE TEN PERCENTUM REALTY TAX SHARES ACCRUING TO BARRIO BILIBOY, ORMOC CITY, AGGREGATING ₱279.12, FOR THE PURCHASE OF LOT NO. 3062 BELONGING TO SPOUSES LEON JAVA AND MARCIANA DANILA FOR BARRIO AND SCHOOL SITE AND FOR OTHER PURPOSES.

BE IT ORDAINED by the Municipal Board of Ormoc City, That:

SECTION 1. The amount of ₱2,720.88, or so much thereof as may be necessary, is hereby appropriated out of funds not otherwise appropriated in the City Treasury to be made available as additional sum to the ten percentum realty tax shares accruing to Barrio Biliboy, Ormoc City, aggregating ₱279.12 (totalling ₱3,000.00) for the purchase of Lot No. 3062, Ormoc Cadastre, with an area of 16,439 square meters belonging to the spouses Leon Java and Marciana Danila for barrio and school site purposes of Biliboy: PROVIDED, HOWEVER, that after purchase the lot shall be titled in the name of the Government of Ormoc City.

SECTION 2. The Honorable City Mayor is hereby authorized to execute the deed of sale for and in behalf of the Government of Ormoc City.

SECTION 3. This Ordinance shall take effect immediately upon its approval.
