ORDINANCE NO. 5

AN ORDINANCE APPROPRIATING P546.80 TO SETTLE OUTSTANDING OBLIGATIONS WITH VARIOUS EMPLOYEES OF THE CITY GOVERNMENT FOR THEIR SALARY DIFFERENCES

BE IT ORDAINED by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of P546.80, or so much thereof as may be necessary, is hereby appropriated out of funds not otherwise appropriated in the City Treasurer to be made available for the settling of obligations with various employees of the City Government for their salary differences in the manner provided hereunder as follows; payable to:

1. Mrs. Narcisa A. Orellano, City Midwife, Health Department,
from P1,680 to P2,160 per annum for the period from October 1, 1965, to June 30, 1966 P 360.00
LESS : GSIS Premium 25.20 P 334.80
2. Mr. Sabiniano Dagar, Janitor-Messenger, Health Department,
from P1,680 to P1,800 per annum for the period from October 1, 1965, to June 30, 1966 90.00
3. Det. Cpl. Vidal Albienda, Ormoc City Police Department,
from P1,980 to P2,400 per annum for the period from January 17 to April 30, 1966 122.00
T O T A L P 546.80

SECTION 2. This Ordinance shall take effect immediately upon approval.
