ORDINANCE NO. 7

AN ORDINANCE APPROPRIATING ₱21.50 FOR THE PAYMENT OF ONE

BE IT ORDAINED by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of ₱21.50, or so much thereof as may be neces-
sary, is hereby appropriated out of funds in the City Treasury not other-
wise appropriated to be made available for payment to the Goodwill Auto
Supply & Hardware of one piece of mercury bulb, 160 Watts, 220 volts,
now installed on Osmeña Street, Ormoc City.
