"RESOLVED, to adopt:

ORDINANCE NO. 8

AN ORDINANCE APPROPRIATING ₱5,141.55 FOR THE PAYMENT OF THE  
RETIREMENT GRATUITY OF MR. QUIRIMON M. TAN, FORMER WATCH-  
MAN OF THE CITY FINANCE DEPARTMENT, UNDER THE PROVISIONS  
OF REPUBLIC ACT NO. 1616, AS FURTHER AMENDED BY RA 3836.

BE IT ORDAINED by the Municipal Board of Ormoc City, That:

1: SECTION 1. The sum of ₱5,141.55, or so much thereof as may be ne-  
cessary, is hereby appropriated out of the unappropriated fund existing  
in the City Treasury to be made available for the payment of the retire-  
ment gratuity of Mr. Quirimon M. Tan, former watchman of the City Finance  
Department, Ormoc City, under the provisions of Republic Act No. 1616, as  
further amended by Republic Act No. 3836, to wit:

Retirement benefits for 20 months .....	₱ 3,441.55
Terminal pay for 10 months .....	1,700.00
TOTAL .....	₱ 5,141.55

SECTION 2. This Ordinance shall take effect upon its approval.
