ORDDINANCE NO. 9

AN ORDINANCE AMENDING ORDINANCE NO. 21, SERIES OF 1966, AMENDING FURTHER ORDINANCE NO. 3, AS LIKEWISE AMENDED BY ORDINANCE.

NO. 26, BOTH SERIES OF 1965, EMTITIED "AN ORDINANCE REGULATING THE OPERATION AND MAINTENANCE OF A THREE WHEELED MOTOR VEHICLE AS A PUBLIC CONVEYANCE IN THE CITY OF ORMOC,

AND FOR OTHER PURPOSES."

BE IT ORDAINED by the Municipal Board of Ormoc City, Philippines, That:

SECTION 1. Paragraph 1, under Section 1-A, of Ordinance No. 21, series of 1966, amending further Ordinance No. 3, as likewise amended by Ordinance No. 26, both series of 1965, entitled, "An Ordinance Regulating the Operation and Maintenance of a Three-Wheeled Motor Vehicle as a Public Conveyance in the City of Ormoc, and for other Purposes," is hereby amended, so as to read as follows:

"SECTION 1-A. The operation or area limit for three-wheeled motor vehicles to carry or transport passengers shall be:

"1) To the Northwest, up to Barrio Linao only;"

SECTION 2. This Ordinance shall take effect immediately upon its approval;
