ORDINANCE NO.

AN ORDINANCE APPROPRIATING P1,000.00 FROM FUNDS NOT OTHERWISE APPROPRIATED TO BE MA DE AVAILABLE FOR SUPPLEMENTAL APPRO-PRIATION AS AID TO THE ORMOC CITY CENTRAL SCHOOL FOR THE IMMEDIATE REPAIR OF THE GRANDSTAND, HOME ECONOMICS BUILD-ING AND TOTTETS IN PREPARATION FOR THE FORTHCOMING LEYTE PROVINCIAL ATHLETIC MEET

BE IT ORDAINED, by the Municipal Board of Ormoc City; That:

SECTION 1. The sum of One Thousand Pesos (\$1,000.00), or so much thereof as may be necessary, is hereby appropriated from out of funds not otherwise appropriated in the city treasury to be made available for supplemental appropriation as aid to the Ormoc City Central School for the immediate repair of the grandstand, home economics building and toilets in preparation for the forthcoming Leyte Provincial Athletic Meet.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
