RESOLUTION NO. 9

"WHEREAS, the Division Superintendent of Schools, this City, has made strong representations with this Honorable Board for some aid to the Ormoc City Central School for the immediate repair of the grandstand, home economics building and toilets considering that the Leyte Provincial Meet is just around the corner and will be held in Ormoc City and to be participated in by six delegations whereby we expect more than a thousand visitors;

"NOW, THEREFORE, on motion of Councilor Porcadilla, seconded by the Floor Leader;

"RESOLVED, to approve the request of the Division Superintendent of Schools, this City, and do, as this Body hereby does, adopt:

ORDINANCE NO. 1

AN ORDINANCE APPROPRIATING ₱1,000.00 FROM FUNDS NOT OTHERWISE APPROPRIATED TO BE MADE AVAILABLE FOR SUPPLEMENTAL APPROPRIATION AS AID TO THE ORMOC CITY CENTRAL SCHOOL FOR THE IMMEDIATE REPAIR OF THE GRANDSTAND, HOME ECONOMICS BUILDING AND TOILETS IN PREPARATION FOR THE FORTHCOMING LEYTE PROVINCIAL ATHLETIC MEET

BE IT ORDAINED, by the Municipal Board of Ormoc City; That:

SECTION 1. The sum of One Thousand Pesos (₱1,000.00), or so much thereof as may be necessary, is hereby appropriated from out of funds not otherwise appropriated in the city treasury to be made available for supplemental appropriation as aid to the Ormoc City Central School for the immediate repair of the grandstand, home economics building and toilets in preparation for the forthcoming Leyte Provincial Athletic Meet.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
