RESOLUTION NO. 41

"RESOLVED, to abolish the positions of one of the two deputy assessors and the deputy clerk of court and do, as this Body hereby does, adopt:

ORDINANCE NO. 10

AN ORDINANCE AMENDING FURTHER SECTION 1 OF ORDINANCE NO. 1, SERIES OF 1967, BY DELETING CERTAIN ITEMS THEREUNDER

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. For purposes of economy, Section 1 of Ordinance No. 1, series of 1967, is hereby amended, further, by deleting the following items thereunder:

1. One of the two positions of Deputy Assessor in Item No. 5 under (C-6) Assessment Department (presently occupied by one Ramon Modina); and
2. The position of Deputy Clerk of Court in Item No. 2 under (C-11) City Court.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
