RESOLUTION NO. 42

"WHEREAS, the Honorable Chairman of the Committee on Police, Fire and Public Safety, Councilor Juanito Kangleon, has reported that in the desire of the Honorable City Mayor to fill up existing vacancies in the Ormoc City Police Department with qualified applicants in accordance with Republic Act No. 4864, otherwise known as the Police Act of 1966, the latter had made strong representations by wire with the National Bureau of Investigation to conduct a training course for qualified applicants for policemen which, to the opinion of this Board, would be beneficial to the City considering the tremendous effect that said training could bestow on the updating or improvement of the efficiency of our city police force;

"WHEREAS, Councilor Kangleon further reported that the National Bureau of Investigation, likewise, in its earnest desire to help improve the standard of the Ormoc City Police Department, had approved the Mayor's request in its reply, also by wire, and that the inclusive dates to cover the training course will be announced later;

"WHEREAS, this august Body is made to understand that in training of this kind to be conducted in Ormoc City, the City Government will have to shoulder the expenses for training materials, board and lodging of instructors from Manila and other places, and other incidental expenses in connection with said training; and

tee on Police, Fire and Public Safety, chaired by Councilor Kangleon, has recommended the sum of Three Thousand Pesos (\$\frac{1}{2}\$,000,00) to be appropriated and/or reverted from funds not otherwise appropriated and from salary savings accruing to the Police Department to cover these incidental expenses in connection with the forthcoming NBI-sponsored training course to be conducted in Ormoc City in the near future;

"NOW, THEREFORE, on motion of Councilor Kangleon, seconded by Councilor Porcadilla;

"RESOLVED, to adopt:

ORDINANCE NO. 11

AN ORDINANCE APPROPRIATING THE SUM OF THREE THOUSAND PESOS (#3,000.00) TO BE MADE AVAILABLE AS SUPPLEMENTAL APPRO-PRIATION FOR TRAINING MATERIALS, BOARD AND LODGING OF INSTRUCTORS, AND OTHER INCIDENTAL EXPENSES IN CONNECTION WITH THE FORTHCOMING NBI-SPONSORED TRAINING FOR QUALIFIED APPLICANTS FOR CITY POLICEMENT TO BE HELD IN ORMOC CITY.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of Three Thousand Pesos (\$3,000.00), or so much thereof as may be necessary, is hereby appropriated and/or reverted from funds not otherwise appropriated in the city treasury and from out of salary savings accruing to the City Police Department, said sum to be made available as supplemental appropriation for training materials, board and lodging of instructors from Manila and other places, and other incidental expenses in connection with the forthcoming NBI-sponsored training for qualified applicants for city policemen to be held in Ormoc City.

SECTION 2. This Ordinance shall take effect immediately upon its approval.

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Director, Mational Bureau of Investigation, Manila, and the Chief of Police, the Commanding Officer of the 352nd PC Company, the City Treasurer and the City Auditor, all of Ormoc City;
