RESOLUTION NO. 47

"WHEREAS, the Honorable Chairman of the Committee on Finance, Councilor Jose G. Navarro, after having been authorized by the Honorable City Mayor to make representations with Mr. and Mrs. Agapito Pongos for the use of a portion of the upper floor of the Velasquez building now belonging to them by the Sixth Municipal Board, has reported that the present owners are willing to receive a monthly rental of One Hundred Pesos (P100.00);

"NOW, THEREFORE, on motion of Councilor Navarro, seconded by Councilor Yrastorza;

"RESOLVED, to adopt:

ORDINANCE NO. 12

AN ORDINANCE APPROPRIATING P550.00 AS SUPPLEMENTAL APPROPRIATION FOR RENTAL OF THE VELASQUEZ BUILDING NOW OWNED BY MR. AND MRS. AGAPITO PONGOS FOR THE PERIOD FROM JANUARY 16 TO JUNE 30, 1968, AND PROVIDING FUNDS FOR THE PURPOSE IN SUBSEQUENT GENERAL APPROPRIATIONS.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of Five Hundred Fifty Pesos (P550.00), or so much thereof as may be necessary, is hereby appropriated out of funds not otherwise appropriated in the city treasury to be made available for supplemental appropriation for the rental of a portion of the Velasquez Building, upper floor, now owned by Mr. and Mrs. Agapito Pongos, at the rate of One Hundred Pesos (P100.00) per month for the period from January 16 to June 30, 1968: PROVIDED, HOWEVER, that funds for the same purpose of the Municipal Board be provided in subsequent general appropriations or city budgets.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
