RESOLUTION NO. 56

"RESOLVED, to adopt:

ORDINANCE NO. 15

AN ORDINANCE APPROPRIATING P300.00 TO BE MADE AVAILABLE AS
SUPPLEMENTAL APPROPRIATION FOR GASOLINE OF THE ORMOC
CITY FIRE DEPARTMENT

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of Three Hundred Pesos (P300.00), or so much thereof as may be necessary, is hereby appropriated out of funds not otherwise appropriated in the City Treasury said sum to be made available as supplemental appropriation for gasoline of the Ormoc City Fire Department;

SECTION 2. This Ordinance shall take effect immediately upon its approval.
