RESOLUTION NO. 14

"WHEREAS, Mr. Alfredo Sajot, Jr., Station Manager of the Ormoc Broadcasting Company, Incorporated, this City, in a communication dated January 9, 1968, has offered the facilities of the company through its Radio Station DYRR for a weekly broadcast of the session of the Sixth Municipal Board at the rate of ₱75.00 per broadcast for airtime cost and talent fees, that is, ₱300.00 a month or ₱3,600.00 per annum;

"WHEREAS, this august Body finds the offer of the Station Manager of the Ormoc Broadcasting Company, Incorporated, quite inviting considering that by putting on the air every session of this Board the general public could feel the presence of the Municipal Board in their midst by simply tuning in to Station DYRR and that the good people of Ormoc will be greatly benefited by letting them know all the goings-on in our weekly deliberations on matters affecting them;

"WHEREAS, the use of the facilities of the Ormoc Broadcasting Company, Incorporated, is really beneficial to the public in general but, nevertheless, the airtime cost and other fees are rather seemingly so high that the City cannot afford to meet the proposed rate unless the company would lower said rate to say, ₱40.00 per broadcast, that is, ₱160.00 a month or ₱1,920.00 per annum;

"WHEREAS, during his appearance before this august Body today Mr. Alfredo Sajot, Jr., the station manager, readily and willingly acceded to the request of the Board that he lowers the rate to ₱40.00 and that Mr. Sajot went as far as offering the services of the news department of the company for free in giving news follow-ups to all important items deliberated upon by the Municipal Board;

"WHEREAS, Mr. Sajot assured this august Body of permanent weekly broadcast of its sessions, regular or special, to the extent of further assuring this Board that in case it holds its session elsewhere he will send his technicians to tape-record said session and replay the same in the evening so much so that the payment of ₱40.00 per broadcast would, in the opinion of this Honorable Board, be more than just and equitable taking into account the benefit that could be realized by this lawmaking body in particular and the City of Ormoc in general;

"NOW, THEREFORE, on motion of Councilor Porcadilla, seconded by Councilors Samson, Tan and Mejia;

"RESOLVED, to avail of the facilities of the Ormoc Broadcasting Company, Incorporated, airing or broadcasting weekly the sessions of the Sixth Municipal Board, regular or special, at the rate of ₱40.00 per broadcast and do, as this Body hereby does, adopt:

ORDINANCE NO. 2

AN ORDINANCE APPROPRIATING THE SUM OF NINE HUNDRED SIXTY PESOS (₱960.00) TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR PAYMENT OF WEEKLY BROADCASTS OF STATION DYRR OF REGULAR OR SPECIAL SESSIONS OF THE SIXTH MUNICIPAL BOARD FOR THE PERIOD IMMEDIATELY BEGINNING NEXT REGULAR SESSION UP TO JUNE 30, 1968.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of Nine Hundred Sixty Pesos (₱960.00), or so much thereof as may be necessary, is hereby appropriated out of funds not otherwise appropriated in the city treasury to be made available as supplemental appropriation for the weekly broadcasts of Radio Station DYRR and other facilities of the Ormoc Broadcasting Company, Incorporated, at the rate of ₱40.00 per broadcast for the period immediately beginning with the next regular session of the Board, January 17, 1968 up to and including the end of the current fiscal year, June 30, 1968: PROVIDED, HOWEVER, That subsequent appropriations shall be made for the ensuing fiscal years for the same purpose.


SECTION 2. This Ordinance shall take effect immediately upon its approval.

ENACTED, January 10, 1968.



"CARRIED UNANIMOUSLY."




