RESOLUTION NO. 65

"WHEREAS, in consonance with the wishes of the buyers and occupants of the public market who have been cooperating with the City Administration the Market Superintendent has, through the Honorable Committee on Markets and Slaughterhouses, requested this august Body, among others, for the improvement of the fish and meat section by way of cementing the area in such a way that the flooring and the steps will no longer be slippery to ward off hazards to said buyers and occupants;

"NOW, THEREFORE, on motion of Councilor Samson, seconded by Councilor Kangleon;

"RESOLVED, to adopt:

ORDINANCE NO. 20

AN ORDINANCE APPROPRIATING ₱75.00 FOR THE PURCHASE OF 15 BAGS OF CEMENT FOR THE IMPROVEMENT OF THE FISH AND MEAT SECTION OF THE PUBLIC MARKET

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of Seventy-Five Pesos (₱75.00), or so much thereof as may be necessary, is hereby appropriated out of funds not otherwise appropriated in the City Treasury to be made available for supplemental appropriation for the purchase of fifteen (15) bags of cement for the purpose of improving the fish and meat section of the public market.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
