RESOLUTION NO. 75

"WHEREAS, the Chief of Fire Department had on January 23, 1968, forwarded to the Office of the City Mayor a report on defective fire hydrants, numbering sixteen all over the City, as submitted by his sergeant, with a request for their immediate repair at the cost of labor and materials as recommended by the plumber of the Ormoc Waterworks System amounting to ₱346.00;

"WHEREAS, this august Body feels the urgency of the request considering that summer is fast approaching and the readiness of these fire hydrants is of primary importance against conflagration;

"NOW, THEREFORE, on motion of Councilor Navarro, seconded by the Floor Leader and Councilors Kangleon and Samson;

"RESOLVED, to approve the request of the Chief of Fire Department and do, as this Body hereby does, adopt:

ORDINANCE NO. 24

AN ORDINANCE APPROPRIATING ₱346.00 FOR THE IMMEDIATE REPAIR
OF 16 DEFECTIVE FIRE HYDRANTS ALL OVER THE CITY

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of Three Hundred Forty-Six Pesos (₱346.00), or so much thereof as may be necessary, is hereby appropriated out of funds not otherwise appropriated in the City Treasury to be made available as supplementary appropriation for the immediate repair of the sixteen (16) defective fire hydrants in the City.

SECTION 2. This Ordinance shall take effect immediately upon its approval.

ENACTED, February 21, 1968.

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Chief of Fire Department, the Waterworks Supervisor, the City Treasurer and the City Auditor, all of Ormoc City;
