The sum of Seventy Pesos (170.00), or so much thereof as may be necessary, is hereby appropriated out of funds not otherwise appropriated in the City Treasury to be made a vailable as supplemental appropriation for the purchase of four (4) mercury bulbs for installation within the fish and meat sections of the public market for better lighting and other purposes.
