"WHEREAS, exigency of service demands that one more casual laborer be employed in the Assessment Department of Ormoc City to assist the said office in its current task of the general revision of assessments;

"NOW, THEREFORE, on motion of Councilor Navarro, seconded by Councilor Kangleon;

"RESOLVED, to adopt:

**ORDINANCE NO. 26**

AN ORDINANCE CREATING THE POSITION OF ONE (1) LABORER IN THE ASSESSMENT DEPARTMENT OF ORMOC CITY WITH COMPENSATION AT THE RATE OF ₱1,800.00 PER ANNUM

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The position of one (1) Laborer is hereby created in the Assessment Department of Ormoc City with compensation at the rate of One Thousand Eight Hundred Pesos (₱1,800.00) per annum.

SECTION 2. Consequent to this creation, the sum of Six Hundred Pesos (₱600.00), or so much thereof as may be necessary, is hereby appropriated out of funds not otherwise appropriated in the City Treasury to be made available as supplemental appropriation for the salary of one laborer up to June 30, 1968: PROVIDED, HOWEVER, that funds for the same purposes shall be appropriated in subsequent general appropriation ordinances.

SECTION 3. This Ordinance shall take effect as of March 1, 1968.
