SECTION 1. The sum of Three Hundred Pesos (#300.00), or so much thereof as may be necessary, is hereby apprepriated out of funds not otherwise appropriated in the City Treasury to be made available as supplemental appropriation for transportation and travel of the Office of the City Mayor.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
