RESOLUTION NO. 81

"WHEREAS, the Office of the City Mayor has, through the Honorable Chairman, Councilor Jose G. Navarro, of the Committee on Finance, made representations with this august Body with a request for an appropriation of P300.00 for travel and transportation because this particular item in the budget has already been exhausted;

"WHEREAS, this august Body understands the urgency of the request considering that travel and transportation is an indispensable item in any department of the City Government especially the Office of the City Mayor;

"NOW, THEREFORE, on motion of Councilor Navarro, seconded by Councilor Kangleon;

"RESOLVED, to adopt:

ORDINANCE NO. 27

AN ORDINANCE APPROPRIATING THE SUM OF THREE HUNDRED PESOS (P300.00) FOR TRAVEL AND TRANSPORTATION OF THE OFFICE OF THE CITY MAYOR

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of Three Hundred Pesos (P300.00), or so much thereof as may be necessary, is hereby appropriated out of funds not otherwise appropriated in the City Treasury to be made available as supplemental appropriation for transportation and travel of the Office of the City Mayor.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
