RESOLUTION NO. 84

"WHEREAS, the Barrio Council of Mahayahay, this City, in its Resolution No. 1 of February 13, 1968, has urgently requested the Honorable City Mayor, through this august Body, for some aid for the immediate repair of the Mahayahay Community School building which has been greatly damaged by typhoon "Welming" last November so much so that presently the Grades I and II classes are often disrupted everytime a heavy rain falls;

"WHEREAS, this Board finds the request of the Barrio Council of Mahayahay really urgent taking into account that the prevailing condition of their community school building is not conducive to (to) better learning and endangers the health of the teachers and pupils;

"NOW, THEREFORE, on motion of Councilor Porcadilla, seconded by Councilor Samson;

"RESOLVED, to approve Resolution No. 1, current series, of the Barrio Council of Mahayahay, Ormoc City, and do, as this Body hereby does, adopt:

ORDINANCE NO. 28

AN ORDINANCE APPROPRIATING P500.00 FOR THE REPAIR OF THE
MAHAYAHAY COMMUNITY SCHOOL BUILDING

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of Five Hundred Pesos (P500.00), or so much thereof as may be necessary, is hereby appropriated out of funds not otherwise appropriated in the City Treasury to be made available as supplemental appropriation for aid to Barrio Mahayahay, Ormoc City, for the repair of the Mahayahay Community School building.

SECTION 2. This Ordinance shall take effect immediately upon its approval.

ENACTED, March 13, 1968.

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Barrio Council of Mahayahay, the City Treasurer and the City Auditor, all of Ormoc City;

"CARRIED. Six affirmative votes registered by the Floor Leader, Councilors Kangleon, Aviles, Samson, Tan and Porcadilla; one abstention registered by Councilor Navarro."
