RESOLUTION NO. 92

"WHEREAS, the Office of the City Engineer has made representations with this august Body for the approval of the construction of the Cantubo Bridge-Aguadulce Bypass Road which project will extend from the Cantubo Bridge in the North to Aguadulce Street in the South passing along the Malbasag Dike intended primarily for heavy trucks hauling tons of sugarcane or gravel and sand thus minimizing the danger to pedestrians especially school children here in the city and also to our principal city streets which, as we see, are always in bad condition especially during milling seasons due to the heavy trucks hauling canes;

"WHEREAS, according to the City Engineer's Office this project needs an initial outlay of at least Five Thousand Pesos to start with the road-right-of-way definition along the Malbasag Dike;

"NOW, THEREFORE, on motion of Councilor Navarro, seconded by Councilors Kangleon and Aviles;

"RESOLVED, to adopt:

ORDINANCE NO. 30

AN ORDINANCE APPROPRIATING ₱5,000.00 AS INITIAL OUTLAY FOR
THE PROPOSED CANTUBO BRIDGE-AGUADULCE BYPASS ROAD
CONSTRUCTION

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of Five Thousand Pesos (₱5,000.00), or so much thereof as may be necessary, is hereby appropriated out of funds not otherwise appropriated in the city treasury to be made available as supplemental appropriation for initial outlay for the proposed construction of the Cantubo Bridge-Aguadulce Bypass Road.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
