RESOLUTION NO. 93

"WHEREAS, after a representation had been made by Councilor Jose C. Aviles with the Engineering Department of Ormoc City, the latter, through Associate Civil Engineer Crispin B. de la Victoria, in a communication dated February 20, 1968, had recommended the amount of one thousand five hundred pesos as sufficient for the investigation, survey, preparation of plans and documents, ratification and registration of road-right-of-way agreements in connection with the proposed construction of Liloan-Licoma-Medalle Tan-Manlilinao Road;

"NOW, THEREFORE, on motion of Councilor Navarro, seconded by Councilors Aviles, Porcadilla and Mejia;

"RESOLVED, to approve the recommendation of the Associate Civil Engineer of the Engineering Department, Ormoc City, and do, as this Body hereby does, adopt:

ORDINANCE NO. 31

AN ORDINANCE APPROPRIATING THE SUM OF ONE THOUSAND FIVE HUNDRED PESOS (P1,500.00) FOR INVESTIGATION, SURVEY, PREPARATION OF PLANS AND DOCUMENTS, RATIFICATION AND REGISTRATION OF ROAD-RIGHT-OF-WAY AGREEMENTS FOR THE PROPOSED LILOAN-LICOMA-MEDALLE TAN-MANLILINAO ROAD CONSTRUCTION

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of One Thousand Five Hundred Pesos (P1,500.00), or so much thereof as may be necessary, is hereby appropriated out of funds not otherwise appropriated in the city treasury to be made available as supplemental appropriation for investigation, survey, preparation of plans and documents, ratification and registration of road-right-of-way agreements in connection with the proposed construction of the Liloan-Licoma-Medalle Tan-Manlilinao Road.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
