RESOLUTION NO. 105

"WHEREAS, it has become imperative to create twenty-one new casual positions in various departments of the City Government for the good of public service;

"NOW, THEREFORE, on motion of Councilor Navarro, seconded by Councilor Kangleon;

"RESOLVED, to adopt:

ORDINANCE NO. 32

AN ORDINANCE CREATING TWENTY-ONE (21) NEW CASUAL POSITIONS IN VARIOUS DEPARTMENTS OF THE CITY GOVERNMENT WITH COMPENSATION AT THE RATE OF ONE THOUSAND EIGHT HUNDRED PESOS (P1,800.00) PER ANNUM EACH AND PROVIDING FUNDS FOR THE PURPOSE FROM MARCH 16 TO JUNE 30, 1968.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The positions of twenty-one (21) new Laborers are hereby created in the various departments of the City Government with compensation at the rate of One Thousand Eight Hundred Pesos (P1,800.00) per annum each, vis-a-vis:

a) (C-1) OFFICE OF THE CITY MAYOR

Four (4) Laborers at P150.00 per month
each effective March 16, 1968 P 2,100.00

b) (C-2) MUNICIPAL BOARD

Four (4) Laborers at P150.00 per month
each effective March 16, 1968 2,100.00

c) (C-5) FINANCE DEPARTMENT

Four (4) Laborers at P150.00 per month
each effective March 16, 1968 2,100.00

d) (C-6) ASSESSMENT DEPARTMENT

Four (4) Laborers at P150.00 per month
each effective March 16, 1968 2,100.00

e) (C-15) POLICE DEPARTMENT

Three (3) Laborers at P150.00 per month
each effective March 16, 1968 1,575.00



f) (C-16) FIRE DEPARTMENT

Two (2) Laborers at ₱150.00 per month
each effective March 16, 1968 ₱ 1,050.00

T O T A L ₱11,025.00

SECTION 2. The sum of Eleven Thousand Twenty-Five Pesos (₱11,025.00), or so much thereof as may be necessary, is hereby appropriated out of funds not otherwise appropriated in the city treasury, said sum to be made available as supplemental appropriation to cover salaries and wages of the twenty-one (21) new casual positions thus created: Provided, That sufficient funds for this purpose shall provided in subsequent general appropriations.


SECTION 3. As is already provided herein, this Ordinance shall take effect as of March 16, 1968.



"CARRIED UNANIMOUSLY."


